

### Coursework Option to Satisfy Subject Matter Competency for the Education Specialist or Multiple Subject Credential Programs

The subject matter competency requirements for the Education Specialist or Multiple Subject Credential Programs can be satisfied by:

- 1. Completing all qualifying coursework as noted in the following pages, OR
- 2. Completing all courses for a specific subtest(s) in combination with a passing score(s) on the other CSET Multiple Subjects subtest(s).

All courses must be completed with a grade of **C** or higher (CR or P is also acceptable). Course requirements may also be met with the following: passing score on equivalent AP or IB exams, articulated community college courses, or CLEP exams.

The following documents must be signed by an Advisor in the <u>SchoolsFirst Federal Credit Union Center</u> for <u>Careers in Teaching</u> in order to be used as evidence of satisfying the subject matter requirements. #### **INSTRUCTIONS:**

If you have <u>completed</u> the required coursework for one or more of the CSET subtests, enter the coursework on the following pages and submit the request for verification per the instructions below.

If you are **currently enrolled in any of the required courses** and are applying to the credential program for an upcoming term, you may request verification before the courses are completed. Please note, final grades will be required to verify subject matter competency and all courses must be completed prior to the start of the credential program in order to complete the requirement for admission to the program.

**REQUIRED COURSE**: Enter the course completed or in progress (or the equivalent, such as an articulated community college course). Enter the course exactly as it shows on your transcript. If you believe you have completed the requirement with a course not included on the list, you must submit course syllabi with this document so that the course can be reviewed for approval.

- **COURSE OR EXAM COMPLETED:** Enter the course or exam you completed for each requirement.
- □ **COMPLETED** @ (institution): Enter the institution at which the course was completed. If the requirement was met by equivalent exam, enter the exam taken.
- □ SEMESTER COMPLETED (Sem/Yr): Enter the term the course was completed (for example "Fall/2019"). If the requirement was met by equivalent exam, enter the date the exam was taken.
- GRADE or SCORE RECEIVED: If the course is currently in progress, enter "IP".
- Attach supporting documentation: Provide copies of transcripts that include any courses listed; provide a copy of official test score reports for any exams listed.
- □ Save this form and all supporting documents in PDF format (preferably as one document).
- □ Save each file as "Last Name\_First Name\_CWID\_Name of document".
  - □ For example: Doe\_Jane\_999999999\_CSUF Transcript"
- Submit all files <u>here</u>.

**Please Note:** Your coursework will be reviewed 10-14 business days after submitting the request if all required documentation is submitted as instructed. Incomplete requests will not be reviewed. You will be contacted via email once the review is completed. Please be sure to include accurate contact information.
