Chair Bedell called the meeting to order at 11:30 AM.

12:30 PM Topic: Program Impaction Presenter: Dr. Ed Sullivan, Assistant Vice President - Institutional Research and Analytical Studies Nancy Dority, Assistant Vice President – Enrollment Services Jessica Wagoner, Director of Admissions Ed Trotter, Associate Vice President – Undergraduate Programs

Chair Bedell welcomed the above-named guests to begin the discussion regarding "Differential Program Impaction". Dr. Sullivan, using PowerPoint slides, directed the conversation of FTES (actual vs. target) graphs and numbers from 2003-04 projected through2013-14. Fall 2013 applications have increased across the CSU. Implementing CSU impaction criteria is necessary to control enrollments by limiting the admission of new students. The Impaction Task Force in 2011 compiled guiding principles for implementing impaction at CSUF. Admission strategies are to maintain a mix of lower and upper division students and majors, taking into consideration the historical balance of freshmen and transfer students and the number of students enrolled in campus programs or majors. CSU types of admission impactions are 1) campus impaction and 2) program impaction. Differential program impaction is program specific admission criteria and standards. This will need further discussion to develop a framework for fall 2014 admissions cycle, since all types of impaction methods have academic and fiscal repercussions for students, faculty, departments, and programs. 2013-14 CSUF impaction approach will likely be similar to 2012-13. Provost and President will begin conversations in January regarding methods of impaction to be considered. Departments and programs are on the frontline for planning continuing challenges in the ongoing budget challenges in the State of California.

VIII. COMMITTEE LIAISON REPORTS

ASI Board of Directors [Bedell] T, 12-11-12 1:15 – 3:30 PM, TSU The ASI Board of Directors met for the final fall 2012 meeting. They appointed several commissioners, e.g., to Lobby Corps and heard several quarterly reports. They elected new officers for spring 2013: Yvette Loaeza – re-elected Chair Harpreet Bath – elected Vice Chair. Given it was my last meeting, I received *their* coveted key chain.

Curriculum Committee [Bruschke] F, 12-7-12, 2:00 - 4:00 PM

The only course on the table, COMM 358, was approved. Much discussion followed about online education, with increasing concerns about CSU Online and MOOCs generally. The course challenge policy will be reviewed at a future meeting.

Extended Education Committee [Pasternack] M, 12-10-12 3:00-3:15 PM

15-minute meeting. We approved the minutes of the last meeting and received a report on Open University enrollments for 2011-12. Overall such enrollments were up 15% over 2010-11 with over 20% gains in ECS (29%) and MCBE (28%). All colleges experienced gains with the exception of Education (-7%). It was unclear what percentage of the Open University enrollments were due to academic disqualification versus other reasons (e.g. international students). Barry Pasternack asked if such a breakdown could be prepared. Barry Pasternack also reported that as part of the upcoming Senate election to replace Chris Manriquez the Senate will be surveying faculty to get their opinion on moving Intersession to May. He noted that any change would not take effect for at least two years. He also reported that the Board of Trustee item on General Education was revised to one that called on campus programs to bring their degree requirements down to 120 semester units (180 quarter units). He indicated that the way this was worded in the Board packet (giving Chancellor's Office staff the authority to make such reductions) was problematic. Additionally, he reported that CSU Online is asking for an additional \$5 million, and it is not clear where these funds would be coming from.

Faculty Affairs Committee [Matz] M, 12-7-12 10:00-12:00, MH-141

The FAC committee met on Friday, December 7th and discussed the following items. The Academic Senate approved the revisions to UPS 211.000 Responsibilities of Department and Department Chairs and UPS 270.103 Staffing of 500-Level Graduate Courses. The Subcommittee on UPS 210.000 Faculty Personnel Policy and Procedures gave an update on their progress for revisions and considerations. A discussion on UPS 290.000 Outstanding Professor Award resulted in questions being forwarded to Jack Bedell on streamlining the process and if it would be in the best interest of the award. UPS 291.000 Distinguished Faculty Member Guidelines was discussed and deferred to collecting more information from the colleges regarding their procedures. There appears to be a variety of how this award is given. The last item for discussion was on whether there should be a new UPS procedure on visiting scholars from the United States as there is for visiting scholars from other countries. To be continued.

The committee has 13 documents to review. To date, two have been sent to Senate and approved.

Information Technology Committee [Walker for Randall] F, 12-7-12 10:00-11:00 AM, PLS-299

The Information Technology Committee met on December 7. The committee is rescheduling their February 1 meeting to February 8 to avoid conflict with the President's Inauguration. Rommel Hidalgo briefly reviewed the division's goals for 2012-2013 (same presentation as PRBC). The primary item of discussion was online administration of student opinion questionnaires (SOQ's). This is an item of continued discussion from the previous IT committee meeting. Also, AVP Faust sent an email on Monday Dec 3 (copied below) outlining changes in the CBA that allow online administration of SOQ's. The committee has a number of concerns regarding the administration of online SOQ's.

- 1. Reduced response rates
- 2. Bias in Response or Error (e.g. Only angry students who dislike your class responding or a student filling out an evaluation for a biology class and thinking it was their psychology class)
- 3. Control over access to SOQ's- In online classes where online SOQ's are administered the faculty get little choice on the timing of administration of SOQ's and the SOQ's are available to the students for 3 weeks. We also learned that colleges and departments may vary quite a bit in the procedures and processes

used for SOQ administration. Some colleges choose dates for SOQ administration and other's let the faculty choose the date for SOQ administration.

4. Impact on Untenured Faculty-If moving from paper and pencil SOQ's to online SOQ's impacts the scores, this could impact their RTP.

The committee would like to see the data on departments that have switched from paper to online student evaluations in traditional classrooms. Several departments have made this switch (e.g. Mathematics). Care should be taken in this discussion to not confuse differences between evaluation scores for online courses with online evaluations with traditional classes done using paper evaluations. The proper metric is a comparison of different methods of SOQ administration (e.g. paper and pencil vs. online) in a course taught using the same method. Chair Grieb will be forwarding a more detailed report to Executive Committee regarding these issues. Also, Executive Committee should note that we've been invited to participate in this process: "While we hope to move in this direction at CSU Fullerton, electronic administration of SOQs will not take place until we have had ample time to fully engage in the shared governance processes, to review the UPS on SOQs, to hear faculty concerns, put safeguards in place (e.g., to ensure that response rates are robust enough to be statistically significant), and to roll out a marketing campaign to both faculty and students."

Dear Faculty Members:

As you know, the CSU and the CFA recently ratified a new Collective Bargaining Agreement. That Agreement includes some changes that will affect faculty personnel matters at CSU Fullerton. In this email, I summarize the changes to the Agreement that affect the administration of Student Opinion Questionnaires (SOQs).

Effective <u>Spring semester 2013</u>, all courses, taught by all faculty (regardless of rank or tenure status) will include SOQ administration. Prior to the recently enacted Agreement, the number of courses that included SOQ administration varied from department to department; now, all courses in all departments will include SOQ administration. This means that you should be aware that all of your courses in **Spring** will include student questionnaires.

Note that Fall 2012 SOQ administration will follow whatever policy was in place in your department prior to this Agreement--so there will be no changes to our practice this semester.

In addition to the change in the frequency of SOQ administration, the new Agreement permits campuses to utilize online SOQs and store results electronically. While we hope to move in this direction at CSU Fullerton, electronic administration of SOQs will not take place until we have had ample time to fully engage in the shared governance processes, to review the UPS on SOQs, to hear faculty concerns, put safeguards in place (e.g., to ensure that response rates are robust enough to be statistically significant), and to roll out a marketing campaign to both faculty and students. Thus, our expectation is that your SOQs will be administered the same way as in the past, for now. However, if the faculty in your department are interested in exploring options for electronic SOQ administration, please contact the FAR office; we hope to help those departments that are ready to move in this direction to do so, when they are ready.
