Enhancing Collegiate Writing in the Post EWP Environment English Writing Proficiency Exam (EWP) Report Back from A.S. 5-17-12

Ad Hoc Committee + University Board on Writing Proficiency

Chair Bedell introduced Associate Dean Fontaine and thanked her for coordinating and leading the combined Ad Hoc Committee and University Writing Board to a final recommendations report as a result of changes in campus upper division writing requirement within UPS 320.020 University Writing Requirements, approved 5-25-12. Dr. Fontaine answered questions regarding the content of the report.

1.	Changes in leadership and membership of University Writing Board on Writing Proficiency
2.	Proposed revisions to the guidelines for Upper Division Writing Courses
3.	Expanding the curriculum to provide a developmental sequence of course
4.	Additional recommendations

Executive Committee members were interested in the multiple levels and implementation of the ideas presented. If the university is committed to writing skills for students, it seems an appropriate time to hire a *Writing Across the Curriculum* Coordinator who would chair this committee, oversee the requirements and related curricula, coordinate with FDC professional development for any faculty teaching upper division writing course, and work in coordination with the Composition Coordinator in the department of English, Comparative Literature, and Linguistics

Members of Exec and the Writing Board agree that the goals for the UDW requirement should be consistent with University Learning Outcomes and that a balance should be reached between establishing appropriate guidelines for courses and requirements and respecting departmental differences and options. Adequate funding will be needed to accomplish recommendations.

Chair Bedell suggested this report be forwarded to the Academic Senate to endorse on an upcoming spring 2013 agenda.

The Academic Senate will be asked to:

- 1) Endorse report and the merits within.
- 2) Suggest an outside reviewer be invited to campus to conduct a programmatic review and provide recommendations as well as input on the recommendations made by our Writing Board/Ad Hoc Committee.
- 3) Endorse revisions to UPS 320.02 University Writing Requirements.
- 4) Create a timetable for implementation / a beginning toward objectives.
