#### I. CALL TO ORDER

Chair Walker called the meeting to order at 12:10 PM following the 10:00-12:00 Town Hall meeting in TSU where updates were given regarding task force implementation of the campus strategic plan.

#### II. URGENT BUSINESS

- 2.1 (Pasternack) Questioned prerequisites for 400 level courses. Is upper division standing an appropriate prerequisite. Over 60 units and completion of learning outcomes constitutes status of "upper division standing". This raises concerns for transfer students. This item will return as Unfinished Business for EC conversation and possible referral to a standing committee for discussion [UCC or ASC] and report back to EC.
- 2.2 (Walker) Using the Google Form sent to and responses received from faculty interested in serving on the following search committees, names were discussed to balance committees to add to Consent Calendar on A.S. agenda 2-6-14.

### III. ANNOUNCEMENTS

- 3.1 (Walicki)
  - Asked about enforcement of campus smoking policy. Chair Walker responded as a member of the
    ongoing steering committee for Directive 18. A soft enforcement policy was agreed upon with
    emphasis on programs to help smokers quit. May Wong will be asked to attend an Academic Senate
    meeting to give an update on committee activities.
  - Musical programs were highlighted for this week and next, and tickets were offered for each
    performance. Divan Consort is having a CD release party on Wednesday, 2-12-14, and will be
    performing Senator Walicki's music. The play "Doll House", directed by Jim Taulli, will be performed
    over three weekends starting 2-21-14 and will also highlight Senator Walicki's music.

### IV. APPROVAL OF MINUTES

5.1 EC Minutes (Draft) 1-28-14

M/S/P (Bonney/Walicki) minutes of 1-28-14 were approved.

Note: Senator Pasternack commented on Provost Report – 1<sup>st</sup> bullet regarding intersession update. Minutes state that a committee will be charged to assess all aspects of our intersession program, which will provide guidance in moving forward. Chair Walker stated that several faculty members from our Extended Education Committee will be asked to serve on this accelerated committee to review and report on broad aspects of intersession.

## V. CHAIR'S REPORT (Walker)

- Comments continue to be received regarding a lack of linkage between TDAs, the Graduate Unit, Academic Programs and the lack of paper trails. A number of items will be added to EC agendas in future
- The Open Hearing for the Proposal for a School of Risk Management and Insurance received positive input. When the report is received from the ad hoc committee, this should be ready to move forward to A.S. after PRBC approval.
- > UCC will be working on high impact practices (HIPs) and issues with various UPS documents.
- > ISLC is working on revisions to two UPS documents on internships and service learning with Senator Dabirian serving as liaison.

Announced that CSUF College of Engineering degree will attempt to lower units to 120.. Senator Guerin (Chair of ASCSU) asked if Dean Unnikrishnan asked for exemption for the ECS 120 units, which is allowed according to Title V and Board of Trustees policy. The deadline has passed for exemption requests. Chair Walker will ask Dean Unnikrishnan to clarify status.

  VP Eanes introduced Roger Sorochty, Interim AVP of SA Retention, who will work with ISLC. Members will also update UPS 411.601 Policy on Academic Internships [6-16-10], which was last revised prior to EO 1064. A subcommittee was formed to begin this UPS revision work.

Kathleen Castelo discussed Carnegie Application review and submission. Submissions are due 4/14/14. The plan is to start gathering information in Feb and complete and submit materials by April.

Dr. Eanes discussed Student Affairs organizational chart and reengineering.

Dawn Macy reported on service learning data from only 17% of our service learning classes. This very small sample yielded 30% increase in graduation rates.

8.3 <u>Student Academic Life Committee [Guerin] T, -2-4-14</u>, 9:00 –10:00 AM MH-14 SALC will finish work on UPS 300.002 Academic Advising Policy in March.

Meredith Basil described advisement and academic support of student athletes. NCAA requirements for student progress toward degree were covered. Jim Donovan talked about the importance of athletics in building CSUF brand recognition. He also talked about the transferable life lessons that student athletes learn. Just over 1% of students are athletes. The graduation rates are similar to our campus grad rates.
