I. CALL TO ORDER

Chair Walker called the meeting to order at 11:33 AM.

II. URGENT BUSINESS

2.1 ASD 14-71 Revised UPS 610.000 Conflict of Interest Policy for Externally Funded Proposals [3-12-96] [Source: COI Com]

Chair Walker discussed needed changes for federal standards for extramural funding. These recurring issues could be alleviated by creating a standing committee charged with oversight of research policies.

EC members agreed that names need to be corrected for currency throughout document before adding ASD 14-71 to Consent Calendar on A.S. agenda 4-17-14. UPS 610.000 Conflict of Interest should be recommended for next year's committee/A.S. business listed in the annual report.
