## PROVOST REPORT

This is a piece of the puzzle in improving our faculty diversity that will allow faculty to communicate to faculty that in all searches it's a priority that they have either worked with students in a student population, have a commitment in their own scholarship to looking at issues connected to our students/student population, have a commitment that is demonstrating equitable pedagogy.
Q: (Walsh) At what point in the search is that filter going to come up? At the end when departments have narrowed down the final candidates or is it early in the process?
A: (Provost) For me it's that everyone understands that no one of the final candidates is approved if they don't meet the criteria.

Q: (Casem) Who decides what counts as having met the criteria?
A: (Provost) They have a process that determine if the criteria is met.

- (Jarvis) I think a resolution wouldn't do it; it should be inserted into UPS 210.001. We can ask the FAC where they want it inserted into the document for the best place in the process.

7.6 Planning, Resource \& Budget Committee [Graewingholt], F, 12-16-22, 1:00-2:30 PM, PLS-299
- ORSP 2021-2022 Activities \& Challenges:

Undergraduate research is a high impact practice. Increasing grant funding and community partnerships are an important part of the campus strategic plan. The five year submission trend is positive with over $\$ 74$ million proposed research funding for 2021-2022. Five year trend for total awards for research are also on an upward trend. Junior Senior applications declined in 2017-2019, but have rebounded in 2020-2021 \& 2021-2022. RSCA Grant applications have dropped in recent years.

- Advising Presentation:

Advising is one of the cores of successful institutional efforts to educate and retain students. Those who see advisors complete their degrees faster and stay in school. Review of current structure as well as proposed recommendations for change and investment in advising across all departments.

- New Program/Course Proposals:
> COMM Sport Media Certificate (Shepard, Brisbane, Meeds):
This program would allow for a certificate in Communications for students interested in Sports Media, Broadcasting, and related areas. There is a strong ESPN+ collaboration and with these additional opportunities, certificate program is in demand and will be an asset to CSUF. Live steaming opportunities for all our students and expands the athletics outreach of campus. Many students are already leaving CSUF with Sports Media aspirations this program helps to formalize and support this further. No funding needed. Support across campus departments. APPROVED by the Committee.
> Music History \& Literature: Changing degree name to Musicology. More encompassing of a word and more in line with what other colleges call their programs. No curricular change, therefore no cost to make this change. APPROVED by the Committee.
> EDD moving online (Elaine Frey): Change to EDD program to allow their two in-person concentrations to move hybrid. This is in line with counterparts in the field and helps attract students that prefer hybrid programs. No curricular change, therefore no cost to make this change. WASC has approved their application. This allows them to move beyond $50 \%$ online, rather than restricting them below $50 \%$. APPROVED by the Committee.
