Topic: Strategic Plan Update

Presenter: Su Swarat

Su Swarat joined the Exec meeting to discuss the CSUF Strategic Plan 2024 -2029: Plan Development Timeline.

Flow chart covered the following:

- Utilize a data-driven approach to guide the planning process
- Engage in review and reflection of the current Strategic Plan to ensure thoughtful transition to the next plan
- Solicit and listen to the voices of all stakeholders on and off campus
- Coordinate through a diverse committee to synthesize and integrate stakeholder voices into the plan

Timeline covered the following:

- Campus: review and reflection (spring 2023)
 - January Strategic Plan 2024-2029 planning launch
 - February campus-wide review of SP 2018-2023 progress: areas of celebration; areas for improvement
 - March campus-wide reflection on the future of CSUF; who we are; where we want to go; what aspirations we have
 - April campus-wide reflection on goals for the next 5 years; what goals we want to accomplish; how we can achieve the goals
- Committee: plan framework development (summer 2023)
- Campus/Committee: plan development, feedback, finalization and launch (fall 2023 spring 2024)

Q: (Walsh) The whole CSU system is readjusting due to under enrollments, so the context is important. Will we have that information from the Chancellor's office by summer?

A: (Swarat) I don't know if we will have the specifics, but I will say yes.

Q: (Jarvis) How do we avoid Chancellor's office dominance of this? The Strategic Plan has fallen by the wayside in light of GI 2025.

A: (Swarat) You could argue the timing is bad, but this could be our opportunity to set what's important for us.

- Q: (Kanel) Do we know when there will be a search for another Chancellor?
- A: (Swarat) No we don't.
- Q: (Swarat) We want to be engaged in this. What is the best way to reach faculty?
- A: (Kanel) Sometimes you have to bypass the chairs to get information to faculty. You need to send an invitation directly to faculty.
- (Dabirian) Offer food
- (Self) Spread it across different days of the week.
- (Dabirian) Have a Zoom option.
- (Milligan) Emailing on a regular basis, not just once.
- (Dabirian) We can look at the class schedules to find an optimum time for faculty
- (Jarvis) A short email with a link to a website with the information.
- (Kanel) Add it to the portal.

- 9.1 Policy on review of MPPs (Discussion item)
 - (Kanel) We were talking about this on the Statewide Faculty Affairs committee, and I asked if anyone
 evaluated their deans and associate deans and if so, how it was done. Evidently, other campuses
 have policies where they do evaluate their deans and associate deans, other than a general survey
 about how you like the leadership. CSU Sacramento and CSU Maritime sent us their policy.
 - Q: (Walsh) What committee would we send this to if we were interested in pursuing drafting a policy? It's not Faculty Affairs Committee or Faculty Personnel Committee. Would it be the Constitution Committee?
 - A: (Jarvis) There are a number of policies that are drafted by Executive Committee.
 - Q: (Kanel) If the dean and associate dean are tenured faculty, why aren't they subject to the 5-year post tenure review like other faculty?
 - A: (Jarvis) Because they aren't currently faculty, they are on suspension from their faculty contract.
 - (Walsh) the Executive Committee will continue to discuss how we are going to approach this. I will let the Provost know we are interested in doing this when I meet with her on Friday.
