Chair Bedell welcomed both Drs. Murray and Faust and thanked each for their respective help working with Interim President Hagan to sign and review Academic Senate Documents (ASD) throughout spring semester. All pending documents have been returned to the Academic Senate.

VPAA Murray addressed UPS 261.000 Emeriti Policy, which has been around for a long time. Presidents Gordon and Hagan were unwilling to sign the revised versions of UPS 261.000 passed by the Academic Senate. There was agreement during discussion that UPS 261.000 (ASD 06-11) should be returned to the Faculty Affairs Committee, along with the following notes to facilitate committee review and revision of this document:

- Definition of "Emeriti" (does not equate to "retired")
- Guidelines (criteria) to bestow Emeriti status for
  - ✓ Full-time faculty (title, rank, years of service)
  - ✓ Part-time faculty (title, rank, years of service)
  - ✓ Administrators
  - ✓ Staff
- Outline procedures for a decision within each category
- Define "norm" for each category
- An exception clause (already in document) gives latitude to the President
- Does Academic Senate have a role in this UPS?
- Can Emeriti status be revoked? [N.B. This has been done]
- Privileges for Emeriti status could be listed in another document to prevent having to revise the actual UPS when a change (major/minor) in privileges is needed.

Senator Guerin reported that the CSU passed a resolution calling for review or creation of campus policies on emeriti faculty. Excerpt below:

RESOLVED: That the Academic Senate of the California State University (ASCSU) encourage individual campuses to review policies regarding emeriti faculty for currency and completeness. Such policies should address

- eligibility/criteria for determining emeritus status,
- the process to acquire emeritus status,
- honors/privileges provided for emeriti faculty,
- responsibilities of emeriti faculty;

Chair Bedell thanked VPAA Murray for his continuing commitment to ongoing faculty searches. Short-term issues (\$\$) must not impede long-term goals critical to the future of CSUF. VPAA reported a net gain this year of 15 new faculty hires We have approval for 30 searches for 2012-13.

They will review to coordinate and how each of the awards are presented and funded. Award amounts should be more congruent so one award is not more important than another.

- 3. UPS 292.000 Faculty Leadership in Collegiality Award [5-6-12]
- 4. UPS 293.000 The Carol Barnes Excellence in Teaching Award [12-12-06]
- 5. New UPS (if approved)
