Topic: Academic Advising / Presentation
Presenter: Dr. Peter Nwosu, AVP Academic Program

Chair Walker welcomed Dr. Nwosu who thanked EC members for the opportunity to give this PowerPoint presentation regarding CSUF Advising from the Office of Academic Programs. The Task Force on Advising has been working over the past several months toward assessing where we are and where we need to be in relation to the WASC concerns regarding improving student advising. Support of Strategic Plan Goals 1 and 2 is critical. SP Goal #1: Comprehensive and coordinated advising.

SP Goal #2: Improve student persistence, increase graduation rates University-wide, and narrow the achievement gap for underrepresented students.

This PP presentation is on its 15<sup>th</sup> iteration with further changes anticipated as conversations continue to various stakeholder groups giving input to strengthen student support in both college academic advising as well as Academic Advisement Center (AAC) and the Career Center. A proposed advising pathway and mandatory advising for undergraduate students has become the front-and-center issue. Institutions must strike a balance between quality and efficiency.

There is a clear message that faculty members need to be involved in advising within majors as well as to be knowledgeable regarding general education. This involves consistent and ongoing faculty training in order to give accurate and clear information to students.

There needs to be IT training for the Common Communication System – Titan Advisors Network (IT data support system – note system). There are differences in major advising within each college on campus.

There is an organizational chart within Academic Advising Center. A graduation specialist with listed functions and roles has been assigned in each college to work alongside assistant deans who have different job descriptions in the various colleges.

AVPAP Nwosu distributed a copy of the 29 page "Advising at CSUF" PP, which is an evolving plan. He encouraged EC members to send him any recommendations/feedback/conversation points for the next iteration of the presentation. He will return to EC in the future to give updates.
